- Different subjects lend themselves to different presentation of materials. I created a presentation on Study Skills Best Practice that I give when students start in the program. I discuss the Ebbinghaus Forgetting Curve and leveraging this principle for use with spaced repetition method of studying. I discuss study techniques that do not work. I review different types of note-taking strategies outlining that each topic may require a different strategy. I provide examples of when charts may be useful, or flashcards, or Cornell Notes, etc. I encourage the use of applications such as Anki that have spaced repetition studying built into the algorithm to remind you when to study each subject. I also created two Infographics to distribute to students for quick reference with study technique best practice. Study Techniques Best Practices, 45 participants. (January 2020 Present).
- When a new faculty is employed with the program, I work with them closely to ensure they know the processes and procedures of the department, college, and university. Some faculty require additional mentoring in terms of teaching, which includes weekly/bi-weekly meetings, continued teaching observation, and written feedback on created materials such as exams, lectures, and assignments.
